Description

The heavy equipment operator uses various pieces of hydraulic and heavy equipment to handle and process and sort scrap iron and metals, including but not limited to excavators, front-end wheel loaders, and material handlers. He/she is responsible for operating and maintaining various machines to ensure the efficient running of production. The equipment operator must be reliable, possess great attention to detail, be able to multi-task, and must adhere to all safety standards pertaining to his/her position. He/she must also be a team player, as all tasks will require close collaboration with co-workers.

Responsibilities and Duties

- Process and sort scrap metal according to foundry and mill requirements
- Feed the necessary material to semi-automated machines
- Unload scrap metal from both customer and company vehicles
- Provide exceptional customer service. Direct customers to the appropriate location and/or individuals, assist with unloading material, and help answer questions
- Ensure incoming material is safe and does not contain hazardous or unacceptable items
- Assist with the loading of company vehicles
- Perform routine inspection, cleaning, and preventive maintenance (including maintenance logs) on assigned equipment, notifying the supervisor or mechanic of any major defects or needed repairs
- Examine equipment performance/output to discover any machine-related mistakes or flaws, addressing any issues that may have occurred during the shift
- Ensure heavy equipment is safely and securely stored at the end of the shift
- Perform all duties in conformance to appropriate safety and security standards
- General labor duties that may include but are not limited to: shoveling, and general clean-up of any area, and physical handling of materials, supplies, etc.
- Must be at work consistently and on time
